HORSES THAT WIN A N/W LAST 4 CONDITIONED OR OPEN CLASS AT NORTHFIELD MAY NOT MOVE DOWN TO A LOWER CONDITION IN THEIR NEXT START, UNLESS THEY CARRY A CLAIMING TAG.

NORTHFIELD PARK RESERVES THE RIGHT TO REFUSE ANY ENTRY IN AN OVERNIGHT RACE.

HORSES ENTERED BY "NON LOCAL TRAINERS" MAY LOSE PREFERENCE TO HORSES ENTERED BY "LOCAL TRAINERS" AT THE DISCRETION OF THE DIRECTOR OF RACING.

DRIVER CHANGES ARE DONE THE NIGHT OF THE DRAW ON NIGHTS WHEN WE HAVE LIVE RACING OR THE NEXT MORNING (9-10 AM) IF THERE IS NO LIVE RACING. DRIVER CHANGES FOR WEDNESDAY ARE DUE AT 8:00 PM SATURDAY NIGHT.
